Subject: Letter of Interest - Building Envelope Consulting Services

The Pennsylvania State University University Park, Pennsylvania

To: Professional Consultants

The Office of Physical Plant at The Pennsylvania State University ("University") is seeking a building envelope consultant to facilitate the development of assessment criteria and standards for evaluation of building envelope systems. At this time, the University is particularly interested in developing these criteria for roofing and windows systems; however, may in the future desire to expand to other systems. The assessment criteria and standards for evaluation are ultimately used for strategic maintenance and capital planning decision making.

In general, the University wishes to closely mimic Army Corps of Engineers asset management models, where appropriate. The goals of the consultant will be to work with a variety of University stakeholders to develop/refine standards, models, algorithms and overall framework for:

- Inventorying of existing assets
- Systematic and consistent methods for assessing asset conditions
- Structured, objective condition rating systems
- Lifecycle determinations
- Rating and ranking procedures
- Objective, data-driven project prioritization

Once the algorithms are established, the data will ultimately be managed via an internally supported platform (not sought in this LOI).

It is the expectation that once these assessment criteria are developed these assets will be assessed by a variety of consultants and/or in-house staff across various Penn State campus locations. As such, these evaluation criteria must be succinctly and clearly defined in a format can be easily understood and transferred.

The University is not seeking, nor will accept, proprietary systems for data collection and management. Additionally, the University is not seeking consultants to perform the assessments at this time. Rather, the consultant is expected to facilitate the development of the standards by which these assets are evaluated.

The consultant must be qualified and prepared to provide a high level of facilitation and gather user input for each asset from a variety of University stakeholders including Work Control, Project Management, Design Services, Campus Planning & Design, Building & Grounds, and Trade Supervisors.



If you are interested in submitting a proposal for these services, please provide the following information:

- 1. Clearly identify the proposed design entities that make up your team and describe their legal structure (ie: joint venture, etc.).
- 2. Provide a statement detailing your team's unique qualifications for this project. Include a sampling of your previous relevant project experience. Clearly identify who from your team is responsible for the examples provided.
- 3. Discuss some of the key issues that, in your opinion, are important in the success in developing these standards and criteria.
- 4. A statement outlining your approach to facilitate this process and the added value to the project as a result of your team's approach.

Submissions shall be no more than five (5) single sided pages total. Include the name and email address of your team's contact individual for this project. The University reserves the right to waive any informality in any or all submissions, and to reject or accept any submission or portion thereof.
